FIBERED THREEFOLDS AND LANG-VOJTA'S CONJECTURE OVER FUNCTION FIELDS

AMOS TURCHET

ABSTRACT. Using the techniques introduced by Corvaja and Zannier in 2008 we solve the non-split case of the geometric Lang-Vojta Conjecture for affine surfaces isomorphic to the complement of a conic and two lines in the projective plane. In this situation we deal with sections of an affine threefold fibered over a curve, whose boundary, in the natural projective completion, is a quartic bundle over the base whose fibers have three irreducible components. We prove that the image of each section has bounded degree in terms of the Euler characteristic of the base curve.

1. Introduction

Lang-Vojta¹ Conjecture (see [Voj87], [CS86, Chapter XV] or [HS00], F.3.5 for a more basic introduction) is one of the most celebrated conjectures in Diophantine Geometry, generalizing to the logarithmic case the well-known Lang's Conjecture (see [Lan83]—in dimension 2 the conjecture is known as the Bombieri-Lang Conjecture). The conjecture predicts degeneracy of S-integral points in varieties of log-general type and reads as follows.

Conjecture 1.1. Let κ be a number field, S a finite set of places containing the archimedean ones. Let X be a quasi-projective variety defined over κ and let $\mathcal{X} \to \operatorname{Spec} \mathcal{O}_{\kappa,S}$ be a model of X over the S-integers. Then, if X is of logarithmic general type, $\mathcal{X}(\mathcal{O}_{\kappa,S})$ is not Zariski dense.

Here a quasi-projective variety is said to be of log-general type if there exists a desingularization $X_1 \to X$ and a compactification \tilde{X} of X_1 such that the boundary divisor $D = \tilde{X} \setminus X_1$ has normal crossing singularities and $K_{\tilde{X}} + D$ is big. If one starts with a presentation $X = Y \setminus D$ for a projective Y, this is equivalent to the existence of a log-resolution Y', D' of the couple Y, D such that $K_{Y'} + D'$ is big.

When X is of dimension 2, since the spectrum of the ring of S-integers has dimension 1, the model \mathcal{X} can be thought of as an arithmetic threefold whose S-integral points correspond bijectively to sections of the structure map such that the image intersects the boundary D over points of S. This geometric viewpoint can be carried over the so-called geometric version of the Lang-Vojta conjecture, i.e.,

where the number field is replaced by a function field of a curve. In these settings the conjecture becomes:

Conjecture 1.2 (Lang-Vojta). Let $\tilde{\mathcal{C}}$ be a smooth projective curve defined over an algebraically closed field κ of characteristic 0, and let S be a finite set of points of $\tilde{\mathcal{C}}$. Let X be a smooth affine surface defined over $\kappa(\tilde{\mathcal{C}})$. If X is of log-general type, then there exists a bound for the degree of images of each section $\tilde{\mathcal{C}} \setminus S \to X$ in terms of the Euler characteristic of $\tilde{\mathcal{C}} \setminus S$.

The curve $C = \tilde{C} \setminus S$ plays the role of the spectrum of the S-integers in Conjecture 1.1 while morphisms $\tilde{C} \setminus S \to X$ correspond to integral points over the function field of the curve \tilde{C} . Conjecture 1.2 asks for a bound of the degree of curves on surfaces of log-general type depending on the genus and the number of points in the pullback of D; this property, after the work of Demailly [Dem97], is often called (weak) algebraic hyperbolicity.

One of the most studied cases is the one in which $\tilde{X} = \mathbb{P}_{\mathbb{C}}^2$, when Conjecture 1.2 predicts weak algebraic hyperbolicity for the complement of a plane curve of degree at least 4. In this situation the split case (see Remark 1.4 for a discussion and definition of $split\ case$) is known when D has degree four and four irreducible components, and follows as an application of Stothers-Mason abc Theorem ([BM86] and [Vol85]). In a different direction, and with different methods, the split case of the conjecture has been proved for very generic D of degree at least five by work of Chen [Che04] and, independently, of Pacienza and Rousseau [PR07]. In [CZ08], Corvaja and Zannier proved, among other things, the three components and degree four split case and state a possible generalization of their main theorem when the divisor D is not defined over the ground field. In this paper we deal with the situation that corresponds, geometrically, to the study of images of curves under sections of a fibered threefold. In particular, the aim of this paper is to prove the following result.

Theorem 1.3. Conjecture 1.2 holds true for $X = \mathbb{P}^2 \setminus D$ where D over $\kappa(\tilde{\mathcal{C}})$ is a quartic bundle over $\tilde{\mathcal{C}}$ such that D_P has three irreducible components that are in general position for each $P \in \tilde{\mathcal{C}} \setminus S$.

We note that recently, in [CZ13], Corvaja and Zannier vastly generalize the results of [CZ08] for affine surfaces admitting a finite dominant map to the two-dimensional torus \mathbb{G}_m^2 . We expect that an approach similar to the one presented here could lead to the extension of these results to the non-split case. It is also worth mentioning that the author, in his Ph.D. Thesis [Tur14], constructed a new method that can deal with the split case for complements of plane curves of degree at least four in \mathbb{P}^2 with few components. However, the new tools used do not seem to extend to the non-split case.

Remark 1.4 (Split and non-split case). Conjecture 1.2 considers integral point on a quasi-projective variety X defined over the function field $\kappa(\tilde{\mathcal{C}})$ of a smooth projective curve $\tilde{\mathcal{C}}$. One can think of X as a family of varieties parametrized by points of $\tilde{\mathcal{C}}$ in the following sense: roughly speaking X is given by a system of polynomial equations with coefficient in $\kappa(\tilde{\mathcal{C}})$; each time the coefficient specializes to a point of κ we obtain a variety defined over κ . If X is a product $Y \times \tilde{\mathcal{C}}$, we will call this the split (or constant) case of the conjecture; as the terminology suggests, this can be reduced to study integral points on the variety Y defined over the base field κ . In

the description above, this means that each specialization of the coefficients gives the same variety Y, i.e., the coefficients are in κ . In particular if $X = \tilde{X} \setminus D$ is split, then both \tilde{X} and D are defined over κ . If, on the other hand, X is not a product, then the coefficient of the system of polynomials defining X do not all belong to κ . In this situation the specialization of such coefficients leads to different varieties over κ ; we will refer to this as the *non-split* case. The results of [CZ08] deal with the split case where, in the above notation, Y is the complement of a conic and two lines in general position in \mathbb{P}^2 . Our results deal with the corresponding non-split problem in which, in particular, D is not defined over κ but over $\kappa(\tilde{\mathcal{C}})$.

We will now describe precisely our result. Denote by κ an algebraically closed field of characteristic 0 over which all algebraic varieties will be defined. Let \mathcal{C} be an affine curve (by which we always mean an integral separated scheme of finite type over $\operatorname{Spec}(\kappa)$) with normalization $\tilde{\mathcal{C}} \setminus S$, for a (unique) smooth complete curve $\tilde{\mathcal{C}}$ and a finite subset S. The Euler characteristic of the affine curve \mathcal{C} is defined as

$$\chi(\mathcal{C}) := \chi_S(\tilde{\mathcal{C}}) = 2g(\tilde{\mathcal{C}}) - 2 + \sharp S,$$

i.e., the Euler characteristic of the curve $\tilde{\mathcal{C}} \setminus S$.

We recall briefly for the reader's convenience the ideas of [CZ08]. Given the affine surface $X = \mathbb{P}^2 \setminus D$, where D is a divisor consisting of a conic and two lines in general position, one can assume that one of the lines is the line at infinity. In such a contest one is led to the study of affine curves in the complement of a line and a conic in the affine plane. Morphisms from an affine curve $\tilde{\mathcal{C}} \setminus S$ to such a surface can be expressed as $f: P \mapsto (u_1(P), y(P))$, for a couple of rational functions u_1, y of $\tilde{\mathcal{C}}$, with the property that the zeros and the poles of u_1 , and the poles of y are contained in S. Using explicit equations for D, one can write down an equation satisfied by these functions and another unit u_2 that is as follows:

$$y^2 = u_1^2 + \lambda u_1 + u_2 + 1.$$

Bounding the degree of the morphism f is then equivalent to bound the height of solutions to the previous equation. Hence the problem relies on solving the equation in so-called S-units u_1, u_2 and S-integer y. For this the authors consider a specific differential form on the curve with respect to which the previous equation can be differentiated. Then one can prove that this new equation should have many zeros in common with the previous one and hence, using a gcd argument for S-units, its solutions have either bounded height or fulfill a dependence relation. In both cases one can conclude the proof of Conjecture 1.2.

We note, passim, that the differential equation obtained by the use of the differential form is of particular interest in the context of relating these results to hyperbolicity problems: notably this equation is strictly related to the problem of finding sections of logarithmic jet differentials, a feature which is essential in results obtained in the complex analytic case (see [Mou12] and [Rou09] for more details).

Remark 1.5. It is natural to ask whether the methods introduced by Corvaja and Zannier can tackle higher dimensional analogues of the Geometric Lang-Vojta Conjecture. Such a generalization can be achieved if more general gcd estimates were available. In particular one would be interested in bounding gcd(f(a, b, c), g(a, b, c)) for (at least) 3 S-units, a, b and c. At the present we are not aware of any result

of this type. We note, however, that the Nevanlinna analogues in higher dimensions for algebraic degeneracy of holomorphic curves are known (see for example [NWY07, Theorem 5.4]).

Our goal in this paper is to generalize this situation to the so-called non-split case, i.e., the case of Lang-Vojta Conjecture for the complement of a conic and two lines in \mathbb{P}^2 , where now the divisor has field of definition strictly bigger than the ground field. As in the split case, we are going to reduce the problem to solve a Diophantine equation and bound the height of its solutions using the Corvaja and Zannier method. In our case, the equation that describes this setting reads as follows:

(1.1)
$$y^2 = u_1^2 + \lambda(P)u_1 + u_2 + 1.$$

Here again y is an S-integer, u_1, u_2 are S-units, and λ will be a rational function on the curve $\tilde{\mathcal{C}}$. We note that this equation is precisely the same considered in [CZ08], where now the polynomial in the right-hand side has non-constant coefficients. Geometrically, this corresponds to the data of an (affine) threefold X, fibered over the curve \mathcal{C} , where each fiber is isomorphic to $\mathbb{P}^2 \setminus D$ and D is a divisor consisting of a conic and two lines. Each solution of the equation (1.1) gives a section of the fibration $X \to \mathcal{C}$. This could be formalized using the theory of integral models, where S-integral points of a variety defined over a function field of a curve correspond to sections of the structure map given by the model, such that the inverse image of the divisor D is supported on S. However, we are not going to use this approach in this article.

The situation we will consider is made explicit in the following diagram:

$$(1.2) \qquad \qquad \sigma \left(\begin{array}{c} X \\ \downarrow^{\pi} \\ \mathcal{C} \xrightarrow{\lambda} \mathbb{P}^{1} \end{array} \right)$$

The parameter $\lambda(P)$ will be a function depending on the divisor on the fiber over P and σ will be a section of the projection π . We observe that in [CZ08], the morphisms considered by Corvaja and Zannier from the affine curve $\mathcal{C} = \tilde{\mathcal{C}} \setminus S$ to $\mathbb{P}^2 \setminus D$ can be seen as sections of the trivial ($\mathbb{P}^2 \setminus D$)-bundle over the curve \mathcal{C} . Here the trivial bundle is replaced by a fibration, in which the divisor at infinity in the fibers is moving. Moreover, generalizing the situation of the constant case, the three irreducible components of the divisor $D = D_P$ are not supposed to be in general position for every $P \in \tilde{\mathcal{C}}$ (although we need some restriction on the "degeneracy" of the divisor).

Our main result, from which Theorem 1.3 follows, is the following.

Theorem 1.6. Let \tilde{C} , S, X be as above. Let $\sigma : C \to X$ be a non-constant section for the fibration $\pi : X \to C$, where each fiber is isomorphic to $\mathbb{P}^2 \setminus D$. Then there exist effectively computable constants C_1, C_2 such that, in a suitable projective embedding of X, the curves $\sigma(\tilde{C})$ verify

$$\deg \sigma(\tilde{\mathcal{C}}) \le C_1 \cdot \chi_S(\tilde{\mathcal{C}}) + C_2.$$

In section 3 we are going to explicitly determine the constant C_1 , C_2 using one natural compactification of the affine variety we are considering. This will result in having the constants depending explicitly on the height of the rational function λ .

Remark 1.7. Readers familiar with [CZ08] will easily recognize a lot of similarity in the proof: one could also say that, a part from some geometric description in the first two sections, we basically cover the same steps carrying out the computations in a different framework. We nevertheless decided to include each intermediate step, even the one much closer to that of Corvaja and Zannier, in order to make this article accessible to all readers.

Notation. We now set the notation for the proofs and we will follow as much as possible the one introduced in [CZ08]. From now on $\tilde{\mathcal{C}}$ will be a smooth complete algebraic curve defined over κ of genus $g = g(\tilde{\mathcal{C}})$ and $S \subset \tilde{\mathcal{C}}$ will be a finite set of points of $\tilde{\mathcal{C}}$. We shall denote by \mathcal{O}_S the ring $\kappa[\tilde{\mathcal{C}} \setminus S]$ of regular functions on the affine curve $\mathcal{C} = \tilde{\mathcal{C}} \setminus S$ and we will call it the ring of S-integers (elements of \mathcal{O}_S are just rational functions on $\tilde{\mathcal{C}}$ with poles contained in the set S). The group of units \mathcal{O}_S^* is called the group of S-units, i.e., rational functions on $\tilde{\mathcal{C}}$ with poles and zeros contained in S. As before we define the Euler characteristic of the affine curve $\mathcal{C} = \tilde{\mathcal{C}} \setminus S$ as $\chi_S(\tilde{\mathcal{C}}) = \chi(\tilde{\mathcal{C}} \setminus S) = 2g(\tilde{\mathcal{C}}) - 2 + \sharp S$.

For any rational function $a \in \kappa(\tilde{\mathcal{C}})$ we define its height to be its degree as a morphism to \mathbb{P}^1 . More explicitly, if we associate to each point $v \in \tilde{\mathcal{C}}$ a discrete valuation of the function field $\kappa(\tilde{\mathcal{C}})$ trivial on κ and normalized, so that its value group is \mathbb{Z} , then the height of a can be expressed as

$$H_{\tilde{\mathcal{C}}}(a) := \sum_{v \in \tilde{\mathcal{C}}} \max\{0, v(a)\},\,$$

where we denoted the valuation with the same letter v. Given a dominant morphism of smooth irreducible projective curves $\tilde{\mathcal{D}} \to \tilde{\mathcal{C}}$, an element $a \in \kappa(\tilde{\mathcal{C}})$ can be viewed as a rational function on $\tilde{\mathcal{D}}$ via the inclusion $\kappa(\tilde{\mathcal{C}}) \subset \kappa(\tilde{\mathcal{D}})$ given by the morphism. The height of a with respect to $\tilde{\mathcal{D}}$ verifies

$$H_{\tilde{\mathcal{D}}}(a) = [\kappa(\tilde{\mathcal{D}}) : \kappa(\tilde{\mathcal{C}})] \cdot H_{\tilde{\mathcal{C}}}(a).$$

2. Configuration of a conic and two lines

In this section we will analyze configurations of a conic and two lines in \mathbb{P}^2 . Our aim is to prove that a moduli space for equivalence classes of these divisors is of dimension one.

Let D be the sum of a smooth conic D_1 and two distinct lines D_2, D_3 in \mathbb{P}^2 defined over κ . This divisor has at most five singular points, four of which lie on the conic, i.e., the four points of intersection between D_1 and $D_2 + D_3$; these points are distinct in the case when D_1, D_2, D_3 are in general position, i.e., D has normal crossing singularities. We want to characterize completely isomorphism classes of such divisors.

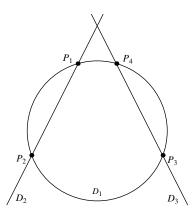


FIGURE 1. Configuration of a conic and two lines in general position

First we observe that each class possesses a representative with a fixed conic $\overline{D_1}$ as a component of degree two. Hence the problem can be reduced to study isomorphism classes of unordered couples of lines not tangent to $\overline{D_1}$ whose intersection is not on the conic. One such divisor is visible in Figure 1. Second one can notice that the problem is equivalent to the study of classes of fourples of points on \mathbb{P}^1 , via the isomorphism between the conic and \mathbb{P}^1 (here we fix the ordering of the lines such that the line D_2 is the one passing through the first two points, and the line D_3 passes through the last two points); we say that two fourples are in the same class if the corresponding unordered couple of unordered couples of points coincide.

This means precisely that the divisors consisting of the fixed conic $\overline{D_1}$ and the lines D_2 and D_3 passing through the ordered points are isomorphic.

A moduli space for our problem will therefore be represented by a scheme with a map from $\mathcal{M}_{0,4} \cong \mathbb{G}_m \setminus \{1\}$, where the last isomorphism is given by the cross-ratio. This follows from the easy observation that fourples with the same cross-ratio are in the same class. However, the map from $\mathcal{M}_{0,4}$ will not be injective: as an example, consider the following two fourples (P_1, P_2, P_3, P_4) and (P_2, P_1, P_3, P_4) , which clearly are in the same class, since

$$\{\{P_1, P_2\}, \{P_3, P_4\}\} = \{\{P_2, P_1\}, \{P_3, P_4\}\},\$$

but their cross-ratios are inverse of each other. Hence we expect the map from the moduli of fourples of points in \mathbb{P}^1 to our moduli space to be many-to-one. To describe it more precisely we use the following basic lemma.

Lemma 2.1. Let $P = (P_1, \ldots, P_4)$ and $Q = (Q_1, \ldots, Q_4)$ be two fourples such that $\underline{P} \neq \underline{Q}$ in $\mathcal{M}_{0,4}$, i.e., they don't have the same cross-ratio. Then, if they are in the same class, i.e., they represent the same divisor, then there exists a permutation σ such that, $\sigma(P) = (P_{\sigma(1)}, \ldots, P_{\sigma(4)}) = Q$, as elements of $\mathcal{M}_{0,4}$.

Hence we are reduced to calculate which permutations of four points give rise to isomorphic configurations of divisors. We can then consider the action of the permutation group S^4 on an ordered set of four points in the projective line, i.e., an element of $(\mathbb{P}^1)^4$; an easy case by case analysis shows that the subgroup of S^4 under which a class of fourples is invariant is $G = \langle (12), (13)(24), (14)(23) \rangle$. Hence, by classic properties of the cross-ratio, the only non-trivial action of G in $\mathcal{M}_{0,4}$ comes from elements of the form $(12) \cdot G$. This corresponds precisely to the example made before, in which the first two points are flipped.

In order to completely describe isomorphism classes of degree four and three component divisors in \mathbb{P}^2 it is sufficient to define a map

$$\lambda': \left\{ egin{array}{l} \mbox{degree four and three} \\ \mbox{component divisors in } \mathbb{P}^2 \end{array} \right\} \longrightarrow \mathbb{P}^1,$$

constant on isomorphic divisors. By the description given above we obtain a natural 2:1 map, from the moduli space $\mathcal{M}_{0,4}$ to the moduli space of degree four and three

component divisors; this map simply associates to each fourple the two lines passing to the four points. With abuse of notation we indicate as λ' the composition

$$\lambda': \mathcal{M}_{0,4} \to \left\{ \begin{matrix} \text{degree four and three} \\ \text{component divisors in } \mathbb{P}^2 \end{matrix} \right\} \to \mathbb{P}^1,$$

which is defined as

$$\lambda'(P_1, P_2, P_3, P_4) = \frac{\beta (P_1, P_2, P_3, P_4)^2 + 1}{\beta (P_1, P_2, P_3, P_4)} - 2$$
$$= \beta (P_1, P_2, P_3, P_4) + \frac{1}{\beta (P_1, P_2, P_3, P_4)} - 2$$

where β is the cross-ratio. We observe that the involution (12) inverts the cross-ratio hence the function λ' is constant on fourples in the same class. The presence of the -2 in the formula comes from the fact that we want the zeros and the poles of λ' to contain all the fourples corresponding to divisors which fail to be normal-crossing; these are precisely the ones in which the cross-ratio is either not defined, or takes values $0, \infty$ and 1.

In our computation we will assume that the set S contains all the points where the fiber has boundary divisor defined by a fourple that is either a pole or a zero of λ' . This will, in particular, allow us to apply Theorem 4.9 and to obtain a stronger result, given the fact that our final result will not depend on the negativeness or positiveness of the Euler characteristic of the base curve. Namely, our bound on the degree of the curves will have a constant term depending on the height of λ but all the constants will not depend on the sign of the characteristic. At the same time, this is not a strong restriction because λ' will be a datum of the variety we want to deal with and hence it does not depend on the method used for the proof (see section 3 for a precise definition of λ and its role in the definition of the threefold X).

With abuse of notation we will sometimes indicate the value $\lambda'(P_1, \ldots, P_4)$ as $\lambda'(D)$ where the configuration of D is defined by the points P_1, \ldots, P_4 on the conic D_1 .

3. Affine threefolds

We are interested in a specific class of affine threefolds fibered over affine curves which generalizes the trivial $\mathbb{P}^2 \setminus D$ -bundle considered in the split case. In more detail we will consider the following class of affine threefolds:

 (\star) X is an affine threefold fibered over the affine curve \mathcal{C} such that the completion of the fibration is the trivial \mathbb{P}^2 -bundle over $\tilde{\mathcal{C}}$. Every fiber $\pi^{-1}(P)$ for a point $P \in \tilde{\mathcal{C}}$ is of the form $\mathbb{P}^2 \setminus D_P$ where D_P is a divisor of \mathbb{P}^2 of degree four consisting of an irreducible conic and two lines such that there are at least four distinct singular points. If the point P is in \mathcal{C} , then the function λ' is regular on D_P , i.e., D_P has normal crossing singularities.

A picture of this situation can be seen in the diagram (1.2).

Example 3.1. Consider a plane smooth affine curve \mathcal{C} in $\mathbb{P}^2_{\mathbb{C}}$. For each point $P \in \mathcal{C}$ let t_P denote the tangent line to \mathcal{C} at P. This defines a fibration over \mathcal{C} in the following way: over a point $P \in \mathcal{C}$ let \mathcal{X}_P be the complement in \mathbb{P}^2 of the divisor formed by a fixed quadric D_1 , the line at infinity D_{∞} (assuming a choice of

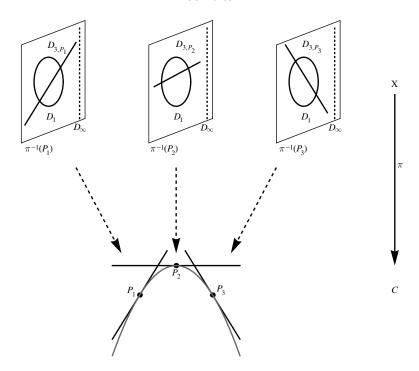


FIGURE 2. Fibered threefold

coordinate has been made) and the line $D_{3,P} = t_P$. A picture of this situation can be seen in Figure 2.

The threefold

$$\mathcal{X} = \bigcup_{P \in \mathcal{C}} \mathcal{X}_P \to \mathcal{C},$$

can be seen as a surface defined over the function field of the smooth completion $\tilde{\mathcal{C}}$ of \mathcal{C} , where a point of the surface $P \in \mathcal{X}(k(\tilde{\mathcal{C}}))$ corresponds to a section $\sigma_P : \tilde{\mathcal{C}} \to \tilde{\mathcal{X}}$ such that $\sigma_P^{-1}(D) \subset \tilde{\mathcal{C}} \setminus \mathcal{C}$. In particular in the case in which the divisor

$$D_P = D_1 + D_{\infty} + D_{3,P}$$

has normal crossing for all $P \in \tilde{\mathcal{C}} \setminus S$, being deg D = 4, each fiber is of log-general type. Therefore, Theorem 1.6 can be applied giving a bound for the degree of images $\sigma_P(\tilde{\mathcal{C}})$ as expected by Conjecture 1.2.

It follows from the definition of the class (\star) that giving such a threefold is equivalent to giving a rational function

$$\lambda: \tilde{\mathcal{C}} \dashrightarrow \mathbb{P}^1,$$

which associates to a point $P \in \tilde{\mathcal{C}}$ a point of \mathbb{P}^1 viewed as the value of the function $\lambda'(D_P)$, i.e., $\lambda(P)$ specifies the isomorphism class of the divisor D_P in the fiber over P. Furthermore each of the affine threefolds we are going to study can be described as follows: we can naturally embed X inside $\tilde{X} := \tilde{\mathcal{C}} \times \mathbb{P}^2$ and denote by $p_1 : \tilde{X} \to \tilde{\mathcal{C}}$ and $p_2 : \tilde{X} \to \mathbb{P}^2$ the two projections. Then the fibration $X \to \mathcal{C}$ is uniquely determined by a line bundle $\mu \in \text{Pic}(\tilde{\mathcal{C}})$ and the choice of a divisor

 $D \in |p_1^*(\mu) \otimes p_2^*(\mathcal{O}_{\mathbb{P}^2}(4))|$; see the diagram below:

We stress that threefolds arising from this construction do not automatically belong to the class (\star) since not every divisor in the linear system gives rise to a fibration where all the fibers $D|_{\pi^{-1}(P)}$ have three components. Conversely, for each such threefold, one can obtain a description as the one given above for a suitable section of $\mathcal{O}_{\mathbb{P}^2}(4)$. This in particular implies that, if X belongs to (\star) , on every fiber the divisor is determined, up to isomorphism, by the value of the function λ defined above, i.e., over every point $P \in \mathcal{C}$ the fiber is uniquely specified by the value of λ' on the singular points of D_P . In other words if $X \to \mathcal{C}$ is one of the threefolds we are interested in, the datum of the map λ completely describes the geometry of X.

In the following section we will prove that every threefold in the class (\star) , characterized by a non-constant rational map $\lambda: \tilde{\mathcal{C}} \dashrightarrow \mathbb{P}^1$, has the property that images of sections have bounded degree in terms of the Euler characteristic of the base curve.

4. Sections of the fibered threefold

From now on we will work on an affine algebraic variety of dimension three verifying condition (\star) . We will denote by D_P the divisor defined on the fiber over the point P (or simply D where the point will be clear) and its three irreducible components will be indicated by D_1 (the conic) and D_2 , D_3 (the two lines). $\lambda: \tilde{\mathcal{C}} \to \mathbb{P}^1$ will denote the morphism $\lambda(P) := \lambda'(D_P)$ and we will suppose that S contains all its zeros and poles. We begin by proving the following.

Lemma 4.1. Let \tilde{C} , S as before and let $\pi: X \to C$ be an affine threefold verifying the condition (\star) . Let $\sigma: C \to X$ be a section of π . Then, possibly after passing to a cover of C of degree 2, there exist S-units $u_1, u_2 \in \mathcal{O}_S^*$ and an S-integer $y \in \mathcal{O}_S$ satisfying

$$(4.1) y^2 = u_1^2 + \lambda u_1 + u_2 + 1,$$

and such that $\deg \sigma(\mathcal{C}) \leq H_{\tilde{\mathcal{C}}}(u_1) + H_{\tilde{\mathcal{C}}}(y)$.

Proof. From condition (\star) it follows that, at most after choosing homogeneous coordinates, we can considered affine coordinates (x,y) in every fiber with respect to the line D_2 that will be the line at infinity $x_0 = 0$. In this coordinate system the line D_3 has equation x = 0 and the conic D_1 has equation $y^2 = x^2 + \lambda x + 1$ (by Tsen's theorem the equations of the two lines can always be chosen in the desired way. However, it could happen that the conic cannot simultaneously be taken to have the former form. In this case we consider a double cover of $\tilde{\mathcal{C}}$ where this holds and perform all the computation in the cover. This will affect only the numerical constants involved in the computation by, at most, a factor of 2). Now

we turn our attention to the section $\sigma: \tilde{\mathcal{C}} \setminus S \to X$. In our setting σ can be written as

$$\sigma(P) = (x(P), y(P), P) \in \pi^{-1}(P) \cong \mathbb{P}^2 \setminus D_P.$$

Now it is a general fact that such a morphism has degree bounded by the height of its components: indeed the degree of σ is the number of intersection points with a generic hyperplane in a projective space where $\sigma(\tilde{\mathcal{C}})$ is embedded and this number is bounded by the sum of the heights of the components x and y. This proves that $\deg \sigma(\mathcal{C}) \leq H_{\tilde{\mathcal{C}}}(u_1) + H_{\tilde{\mathcal{C}}}(y)$ where $u_1 := x$. The fact that the image $\sigma(P)$ avoids the line D_2 means that the function $u_1 := x \in \mathcal{O}_S^*$ is a unit and $y \in \mathcal{O}_S$ is a regular function on the affine curve \mathcal{C} . Moreover, the condition that the image of σ avoids also the conic D_1 in every fiber means that we can define another S-unit u_2 where

$$u_2 = y^2 - u_1^2 - \lambda u_1 - 1.$$

Hence the units u_1, u_2 and the S-integer y verify equation (4.1), concluding the proof.

We will now work with equation (4.1) in order to describe its solutions. Our goal is to prove the following.

Theorem 4.2. With the notation above, every solution $(y, u_1, u_2) \in \mathcal{O}_S \times (\mathcal{O}_S^*)^2$ of equation (4.1) satisfies one of the following conditions:

- (i) a subsum on the right term of (4.1) vanishes;
- (ii) u_1, u_2 verify a multiplicative dependence relation of the form $u_1^r \cdot u_2^s = \mu$, where $\mu \in \kappa^*$ is a scalar and r, s, are integers, not both zero, such that $\max\{r, s\} \leq 5$;
- (iii) the following bound holds:

$$\max\{H_{\tilde{\mathcal{C}}}(u_1),H_{\tilde{\mathcal{C}}}(u_2)\} \leq 2^{12} \left(58\chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)\right) + 16H_{\tilde{\mathcal{C}}}(\lambda).$$

Remark 4.3. Note that the first two conditions are necessary for the theorem to hold. As in the constant case, the image of a section could be a \mathbb{G}_m possessing a non-trivial S-unit. Multiplication by such a unit gives rise to maps to the same \mathbb{G}_m with higher height, for which the bound (iii) does not hold.

Such an example could be made explicit in the following way: consider a plane smooth conic \mathcal{C} and a line D_2 not tangent to the conic. Given a rational parametrization (X(t),Y(t)) of \mathcal{C} one can define a sheaf of lines through a point P in $D_2\setminus\mathcal{C}$ parametrized by \mathbb{P}^1 that associate to each $t \in \mathbb{P}^1$ the line D_t passing through Pand (X(t), Y(t)). We can also assume to scale the parametrization such that the points corresponding to 0 and ∞ are $\{Q_1, Q_2\} = D_2 \cap \tilde{\mathcal{C}}$. This defines a quartic bundle over $\tilde{\mathcal{C}} \cong \mathbb{P}^1$ where the fibers over each point consist of the conic $\tilde{\mathcal{C}}$, the line D_2 and the line D_t . With our choices, over all points different from 0 and ∞ the quartic has normal crossing singularities. In particular we can define an affine threefold fibered over $\mathcal{C}\setminus\{Q_1,Q_2\}\cong\mathbb{G}_m$ as the complement of the total space of the quartic bundle inside $\mathbb{P}^2 \times \tilde{\mathcal{C}}$. Such a threefold verifies condition (\star) . Now one can consider a conic passing through Q_1, Q_2 and tangent to $\tilde{\mathcal{C}}$ in those points. Given a rational parametrization of such a conic one can define a section σ of the threefold whose image is such a conic, in a way that $\sigma(t)$ intersect the divisor D_t only over the points t=0 and $t=\infty$. Therefore its image is \mathbb{G}_m . Now composing with a non-trivial unit we can construct sections that do not verify the height bound (iii)

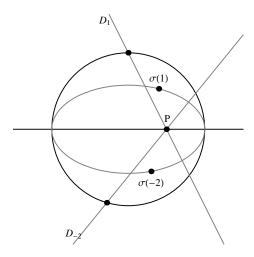


Figure 3. Qualitative picture of Remark 4.3

of Theorem 4.2 but that will verify the relationship (ii). A qualitative picture of such an example can be seen in Figure 3.

We will now follow the proof, given by Corvaja and Zannier, of the constant case deepening the differences between our situation and the ideas of [CZ08]. First we observe that we can define a differential form on $\tilde{\mathcal{C}}$ such that we can speak of derivatives of rational functions. In particular we have the following (this is Lemma 3.5 and Lemma 3.6 of [CZ08]).

Lemma 4.4. There exists a differential form $\omega \in \tilde{\mathcal{C}}$ and a finite set $T \subset \tilde{\mathcal{C}}$ of cardinality $\sharp T = \max\{0, 2g(\tilde{\mathcal{C}}) - 2\}$ such that for every $u \in \mathcal{O}_S^*$ there exists an $(S \cup T)$ -integer $\theta_u \in \mathcal{O}_{S \cup T}$ having only simple poles such that

(4.2)
$$\frac{d(u)}{u} = \theta_u \cdot \omega, \qquad H_{\tilde{\mathcal{C}}}(\theta_u) \le \chi_S(\tilde{\mathcal{C}}).$$

Moreover if $a \in \mathcal{O}_S$, then there exists an $a' \in \mathcal{O}_{S \cup T}$ such that

$$d(a) = a' \cdot \omega,$$
 $H_{\tilde{c}}(a') \le H_{\tilde{c}}(a) + \chi_S(\tilde{C}).$

For the proof of this lemma we refer again to [CZ08]; we just notice that Lemma 4.4 refers to the curve only, without any reference to the bundle, and hence can be applied in all the cases under consideration. From now on the differential form ω and the finite set T will be fixed and, for a rational function $a \in \kappa(\tilde{\mathcal{C}})$ we will denote by a' the only rational function such that $d(a) = a' \cdot \omega$.

We consider now the derivative of a polynomial $A \in \kappa[X, Y]$ calculated in a point u_1, u_2 for some S-units u_1, u_2 . One can prove that (see [CZ08, Lemma 3.7])

$$(A(u_1, u_2))' = B(u_1, u_2),$$

where

$$B(X,Y) = \frac{u_1'}{u_1} \cdot X \frac{\partial A}{\partial X}(X,Y) + \frac{u_2'}{u_2} \cdot Y \frac{\partial A}{\partial Y}(X,Y).$$

We will use this identity in order to deal with equation (4.1).

Lemma 4.5. Let

(4.3)
$$A(X,Y) = X^{2} + \lambda X + Y + 1,$$
$$B(X,Y) = 2 \frac{u'_{1}}{u_{1}} X^{2} + \lambda \left(\frac{u'_{1}}{u_{1}} + \frac{\lambda'}{\lambda}\right) X + \frac{u'_{2}}{u_{2}} Y$$

be polynomials in $\mathcal{O}_{S\cup T}(\tilde{\mathcal{C}})[X,Y]$, and let $F(X) \in \mathcal{O}_{S\cup T}[X]$, $G(Y) \in \mathcal{O}_{S\cup T}[Y]$ be the resultants of A(X,Y), B(X,Y) with respect to Y and X, i.e., the polynomials (4.4)

$$F(\mathbf{X}) = \text{Res}_Y(A, B) = \mathbf{X}^2 \left(2 \frac{u_1'}{u_1} - \frac{u_2'}{u_2} \right) + \mathbf{X} \left(\frac{u_1'}{u_1} - \frac{u_2'}{u_2} + \frac{\lambda'}{\lambda} \right) \lambda - \frac{u_2'}{u_2},$$

$$G(\mathbf{Y}) = \operatorname{Res}_{X}(A, B) = \mathbf{Y}^{2} \left(2 \frac{u_{1}'}{u_{1}} - \frac{u_{2}'}{u_{2}} \right)^{2} + \mathbf{Y} \left[\left(\frac{u_{1}'}{u_{1}} \right)^{2} (8 - \lambda^{2}) + \frac{u_{1}'}{u_{1}} \frac{u_{2}'}{u_{2}} (\lambda^{2} - 4) \right] + \lambda^{2} \frac{\lambda'}{\lambda} \left(\frac{\lambda'}{\lambda} - \frac{u_{2}'}{u_{2}} \right) + \left(\frac{u_{1}'}{u_{1}} \right)^{2} (4 - \lambda^{2}) + \lambda^{2} \left(\frac{\lambda'}{\lambda} \right)^{2}.$$

Then for every solution $(y, u_1, u_2) \in \mathcal{O}_S \times (\mathcal{O}_S^*)^2$ of (4.1) we have

$$y^2 = A(u_1, u_2),$$

 $2yy' = B(u_1, u_2).$

Moreover the S-integer y divides both $F(u_1)$ and $G(u_2)$ in the ring $\mathcal{O}_{S \cup T}$.

Proof. Obviously equation (4.1) is exactly $y^2 = A(u_1, u_2)$. Moreover $A(u_1, u_2)' = B(u_1, u_2)$ so we have $2yy' = B(u_1, u_2)$ as wanted.

For the second fact we observe that, for the general theory of resultants, F and G are linear combinations of A and B with coefficients that are polynomials in $\mathcal{O}_{S \cup T}$, concluding the proof.

Our next step is to factor the polynomials F(X), G(Y) in a suitable finite field extension of $\kappa(\tilde{\mathcal{C}})$; this extension will be a function field $\kappa(\tilde{\mathcal{D}})$ for a cover $\tilde{\mathcal{D}} \to \tilde{\mathcal{C}}$. Besides, we will estimate the Euler characteristic of the curve $\tilde{\mathcal{D}}$. From now on we will suppose that the leading and the constant term of the polynomial F(X), G(Y) are both non-zero.

Lemma 4.6. Given F, G, \tilde{C}, S, T as before, there exists a cover $\tilde{D} \to \tilde{C}$, of degree less or equal to four, such that the Euler characteristic of $\tilde{D} \setminus U$ verifies

$$(4.6) \chi_U(\tilde{\mathcal{D}}) \le 53\chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda) + 5 \cdot \max\{0, 2g(\tilde{\mathcal{C}}) - 2\},$$

where U is the set formed by the preimages of the zeros of the leading and constant coefficients of F and G and the preimages of S and T.

Proof. Our goal was to factor F(X) and G(X), so we define the cover $p: \tilde{\mathcal{D}} \to \tilde{\mathcal{C}}$ by the property that $\kappa(\tilde{\mathcal{D}})$ is the splitting field of $F(X) \cdot G(X)$ over $\kappa(\tilde{\mathcal{C}})$. From this definition it is straightforward that deg p is at most four, because $\kappa(\tilde{\mathcal{D}})$ is generated over $p^*(\kappa(\tilde{\mathcal{C}}))$ by the square roots of the discriminants of the two polynomials (recall that F(X) and G(X) both have degree 2).

We will now bound the Euler characteristic of $\mathcal{D} \setminus U$ via the Riemann-Hurwitz formula; for this goal we need an estimate of the ramification points of the cover p. First we notice that the ramification points are all contained in the zeros and poles

of the discriminants; moreover at any point the ramification index is at most two. The poles are contained in $S \cup T$ and the number of zeros of the discriminants is bounded by their heights. The discriminant of F(X) is (4.7)

$$\operatorname{Discr}(F(X)) = \left(\frac{u_2'}{u_2}\right)^2 (\lambda^2 - 4) + \left(\frac{u_2'}{u_2}\right) \left(8\frac{u_1'}{u_1} - 2\frac{u_1'}{u_1}\lambda^2 - 2\lambda\lambda'\right) + \left(\lambda\frac{u_1'}{u_1} + \lambda'^2\right)^2,$$

so its height (which can be estimated counting its possible poles) is bounded by

$$H_{\tilde{\mathcal{C}}}(\operatorname{Discr}(F(X))) \leq 2H_{\tilde{\mathcal{C}}}\left(\frac{u_2'}{u_2}\right) + 2H_{\tilde{\mathcal{C}}}\left(\frac{u_1'}{u_1}\right) + 2H_{\tilde{\mathcal{C}}}(\lambda') + 2H_{\tilde{\mathcal{C}}}(\lambda)$$

$$\leq 6\chi_S(\tilde{\mathcal{C}}) + 4H_{\tilde{\mathcal{C}}}(\lambda).$$

Analogously, we can look at the discriminant of G(X),

$$Discr(G(X)) = \left(\frac{u_2'}{u_2}\right)^2 \left[\left(\frac{u_1'}{u_1}\right)^2 \lambda^2 (4 - \lambda^2) + \frac{u_1'}{u_1} \lambda \lambda' (8 - 2\lambda^2) + \lambda'^2 (\lambda^2 - 4) \right]$$

$$+ 2 \frac{u_2'}{u_2} \left[\left(\frac{u_1'}{u_1}\right)^3 \lambda^2 (4 - \lambda^2) \left(\frac{u_1'}{u_1}\right)^2 \lambda \lambda' (\lambda^2 - 8) + \frac{u_1'}{u_1} \lambda'^2 (4 + \lambda^2) - \lambda \lambda' \right]$$

$$+ \left(\frac{u_1'}{u_1}\right)^4 \lambda^2 - 2 \left(\frac{u_1'}{u_1}\right)^2 \lambda^2 \lambda'^2 + \lambda'^4,$$

$$(4.8)$$

and bound its height in the same way, obtaining that $H_{\tilde{\mathcal{C}}}(\operatorname{Discr}(G(X)))$ is bounded above by

$$2H_{\mathcal{C}}\left(\frac{u_2'}{u_2}\right) + 4H_{\tilde{\mathcal{C}}}\left(\frac{u_1'}{u_1}\right) + 4H_{\tilde{\mathcal{C}}}(\lambda') + 4H_{\tilde{\mathcal{C}}}(\lambda) \le 10\chi_S(\tilde{\mathcal{C}}) + 8H_{\tilde{\mathcal{C}}}(\lambda).$$

Therefore the number of ramification points is at most

$$\sharp (S \cup T) + 16\chi_S(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda).$$

We can now apply the Riemann-Hurwitz formula

(4.9)
$$2g(\tilde{\mathcal{D}}) - 2 = (\deg p)(2g(\tilde{\mathcal{C}}) - 2) + \sum_{P \in \tilde{\mathcal{D}}} (e_P - 1).$$

Here e(P) is the ramification index of p at P and thus $(e_P - 1)$ is either zero or one. By the above estimate of the ramification points of p we obtain that

(4.10)
$$\sum_{P \in \tilde{\mathcal{D}}} (e_P - 1) \le \sharp (S \cup T) + 16\chi_S(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda).$$

Consider now the set $U\subset \tilde{\mathcal{D}}$ introduced in the statement of the lemma. We have that

$$\sharp U \leq [\kappa(\tilde{\mathcal{D}}) : p^{\star}(\kappa(\tilde{\mathcal{C}}))] \cdot \sharp p(U).$$

From this inequality and from (4.9) and (4.10) the following holds:

$$\begin{split} 2g(\tilde{\mathcal{D}}) - 2 + \sharp U &\leq (\deg p) \bigg(2g(\tilde{\mathcal{C}}) - 2 + \sharp p(U) \bigg) + \sharp (S \cup T) + 16\chi_S(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda) \\ &= (\deg p) \bigg(2g(\tilde{\mathcal{C}}) - 2 + \sharp (S \cup T) + \sharp (p(U) \setminus (S \cup T) \bigg) \\ &+ \sharp (S \cup T) + 16\chi_S(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda) \\ &\leq 4\chi_{S \cup T}(\tilde{\mathcal{C}}) + 4\sharp (p(U) \setminus (S \cup T)) + \sharp (S \cup T) + 16\chi_S(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda). \end{split}$$

We have to bound the number $\sharp(p(U)\setminus(S\cup T))$, but the points in the image of U that are not in $S\cup T$ are precisely the zeros of the leading and constant terms in F(X) and G(X). Again we can estimate their number by looking at the height of these terms. We obtain that

$$\begin{split} \sharp(p(U)\setminus(S\cup T)) &\leq H_{\tilde{\mathcal{C}}}\bigg(2\frac{u_1'}{u_1}-\frac{u_2'}{u_2}\bigg) + H_{\tilde{\mathcal{C}}}\bigg(\frac{u_2'}{u_2}\bigg) + 2H_{\tilde{\mathcal{C}}}\bigg(2\frac{u_1'}{u_1}-\frac{u_2'}{u_2}\bigg) \\ &\quad + H_{\tilde{\mathcal{C}}}\bigg(\bigg(\frac{u_1'}{u_1}\bigg)^2(4-\lambda^2) + \lambda'^2\bigg) \\ &\leq 4\chi_S(\tilde{\mathcal{C}}) + H_{\tilde{\mathcal{C}}}\bigg(\bigg(\frac{u_1'}{u_1}\bigg)^2(4-\lambda^2) + \lambda'^2\bigg) \\ &\leq 8\chi_S(\tilde{\mathcal{C}}) + 4H_{\tilde{\mathcal{C}}}(\lambda). \end{split}$$

Taking this into account we can return to the previous inequality to finish our proof:

$$\chi_{U}(\tilde{\mathcal{D}}) \leq 4\chi_{S \cup T}(\tilde{\mathcal{C}}) + 32\chi_{S}(\tilde{\mathcal{C}}) + 16H_{\tilde{\mathcal{C}}}(\lambda) + \sharp S + \sharp T + 16\chi_{S}(\tilde{\mathcal{C}}) + 12H_{\tilde{\mathcal{C}}}(\lambda)$$

$$\leq 52\chi_{S}(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda) + 5\sharp T + \sharp S$$

$$\leq 53\chi_{S}(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda) + 5\max\{0, 2g(\tilde{\mathcal{C}}) - 2\}.$$

The next step in the proof of our main result is an application of a theorem by Corvaja and Zannier concerning the "greatest common divisor" of two rational functions on $\tilde{\mathcal{C}}$ of the form a-1 and b-1 where a and b are units with respect to some specified finite set (in our case the set will be U). This result is the function field analogue of a theorem by the same authors obtained in the arithmetic case (see [CZ08]) and it should be remarked that this result is linked to Lang-Vojta's conjecture as pointed out by Silverman in [Sil05]. We will need a corollary of this deep theorem as stated in [CZ08, Corollary 2.3] which read as follows.

Theorem 4.7 (Corvaja and Zannier). Let $a, b \in \mathcal{O}_S^*$ not both constant, and let $H := \max\{H(a), H(b)\}$. Then

(i) If a, b are multiplicatively independent, we have

$$(4.11) \quad \sum_{v \notin S} \min\{v(1-a), v(1-b)\} \le 3\sqrt[3]{2} (H(a), H(b)\chi(\mathcal{C}))^{\frac{1}{3}} \le 3\sqrt[3]{2} (H^2\chi(\mathcal{C}))^{\frac{1}{3}}.$$

(ii) If a,b are multiplicatively dependent, let $a^r = \mu b^s$ be a generating relation. Then either $\mu \neq 1$ and $\sum_{v \notin S} \min\{v(1-a), v(1-b)\} = 0$ or $\mu = 1$ and

$$(4.12) \qquad \sum_{v \in S} \min\{v(1-a), v(1-b)\} \le \min\left\{\frac{H(a)}{|s|}, \frac{H(b)}{|r|}\right\} \le \frac{H}{\max\{|r|, |s|\}}.$$

We are going to apply this theorem for a suitable choice of the units a and b: these units will be chosen in such a way that their heights will be "close" to the heights of u_1, u_2 and such that the sum appearing in the statement of Theorem 4.7 gives an upper bound for $\sum_{v \in \tilde{\mathcal{D}} \setminus U} v(y)$. We begin by proving the following.

Lemma 4.8. Let (u_1, u_2, y) be a solution of equation (4.1) (recall that we are supposing that the leading and constant coefficients of F, G are both non-zero). Let $\tilde{\mathcal{D}}, U$ be as before. Then there exist U-units $a, b \in \kappa(\tilde{\mathcal{D}})$ such that

$$(4.13) \quad \left| \max\{H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b)\} - \max\{H_{\tilde{\mathcal{D}}}(u_1), H_{\tilde{\mathcal{D}}}(u_2)\} \right| \le 32 \cdot \chi_S(\tilde{\mathcal{C}}) + 8H_{\tilde{\mathcal{C}}}(\lambda)$$
and

(4.14)
$$\sum_{v \in \tilde{\mathcal{D}} \setminus U} \min\{v(1-a), v(1-b)\} \ge \frac{1}{4} \cdot \sum_{v \in \tilde{\mathcal{D}} \setminus U} v(y).$$

Moreover, $a = u_1 \alpha^{-1}$, $b = u_2 \beta^{-1}$ for suitable α, β such that $F(\alpha) = G(\beta) = 0$.

Proof. Since the field $\kappa(\tilde{\mathcal{D}})$ defined as the splitting field for the polynomial $F(X) \cdot G(X)$, we can write the two polynomials as

$$F(X) = \left(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\right)(X - \alpha) \cdot (X - \bar{\alpha}),$$

$$G(X) = \left(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\right)^2 (X - \beta) \cdot (X - \bar{\beta}).$$

We claim that the roots $\alpha, \bar{\alpha}$ (resp. $\beta, \bar{\beta}$) of F (resp. G) are U-units. This follows from the definition of U (see Lemma 4.6), because the leading and constant coefficients of the two polynomials are U-units. We consider now the following polynomials obtained from F and G dividing by $\alpha \bar{\alpha} \left(2 \frac{u_1'}{u_1} - \frac{u_2'}{u_2} \right)$ and $\beta \bar{\beta} \left(2 \frac{u_1'}{u_1} - \frac{u_2'}{u_2} \right)^2$, respectively, i.e., the polynomials

$$\overline{F}(X) := (X\alpha^{-1} - 1)(X\bar{\alpha}^{-1} - 1),$$

 $\overline{G}(X) := (X\beta^{-1} - 1)(X\bar{\beta}^{-1} - 1).$

Now, by Lemma 4.5, the *U*-integer y divides both $F(u_1)$ and $G(u_2)$, and hence it divides the polynomials $\overline{F}(u_1)$ and $\overline{G}(u_2)$ in the ring of *U*-integers. From this it follows that

$$\sum_{v \in \tilde{\mathcal{D}} \backslash U} \min \{ v(u_1 \alpha^{-1} - 1) + v(u_1 \bar{\alpha}^{-1} - 1), v(u_2 \bar{\beta}^{-1} - 1) + v(u_2 \bar{\beta}^{-1} - 1) \} \ge \sum_{v \in \tilde{\mathcal{D}} \backslash U} v(y).$$

We want to analyze the left-hand side term of the last inequality: observe that for every fourple of rational functions W_1, W_2, Z_1, Z_2 one has (we omit the valuations)

$$\sum_{v} \min\{W_1 + W_2, Z_1 + Z_2\} \le \sum_{\{i,j\} \in \{1,2\}} \sum_{v} \min\{W_i, Z_j\} \le 4 \sum_{v} \min\{\tilde{W}, \tilde{Z}\},$$

for suitable $\tilde{W} \in \{W_1, W_2\}$ and $\tilde{Z} \in \{Z_1, Z_2\}$. In our case we obtain that there exist U-units $a \in \{u_1\alpha^{-1}, u_1\bar{\alpha}^{-1}\}$ and $b \in \{u_2\beta^{-1}, u_2\bar{\beta}^{-1}\}$ such that

$$4\sum_{v\in\tilde{\mathcal{D}}\setminus U}\min\{v(a-1),v(b-1)\}\geq \sum_{v\in\tilde{\mathcal{D}}\setminus U}v(y),$$

proving (4.14). Next we want to prove that the heights of these U-units a, b are "close" to the heights of u_1, u_2 . We observe that the difference appearing in the

left-hand side term of (4.13) is bounded by the maximum of the $\tilde{\mathcal{D}}$ -heights of the roots of F and G. Again we bound these heights by estimating their possible poles. It is then sufficient to observe that the poles of the roots $\alpha, \bar{\alpha}$ (resp. $\beta, \bar{\beta}$) are either zeros of the leading coefficient or poles of the constant term of the polynomial F (resp. G). Hence

$$\begin{split} \max\{H_{\tilde{\mathcal{D}}}(\alpha), H_{\tilde{\mathcal{D}}}(\bar{\alpha})\} &\leq H_{\tilde{\mathcal{D}}}\bigg(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\bigg) + H_{\tilde{\mathcal{D}}}\bigg(\frac{u_2'}{u_2}\bigg) \\ &\leq 4H_{\tilde{\mathcal{C}}}\bigg(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\bigg) + 4H_{\tilde{\mathcal{C}}}\bigg(\frac{u_2'}{u_2}\bigg) \\ &\leq 8\chi_s(\tilde{\mathcal{C}}). \end{split}$$

In the same way we get

$$\begin{aligned} \max\{H_{\tilde{\mathcal{D}}}(\beta), H_{\tilde{\mathcal{D}}}(\bar{\beta})\} &\leq H_{\tilde{\mathcal{D}}}\left(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\right)^2 + H_{\tilde{\mathcal{D}}}\left[\left(\frac{u_1'}{u_1}\right)^2(4 - \lambda^2) + \lambda'^2\right] \\ &\leq 4H_{\tilde{\mathcal{C}}}\left(2\frac{u_1'}{u_1} - \frac{u_2'}{u_2}\right)^2 + 4H_{\tilde{\mathcal{C}}}\left[\left(\frac{u_1'}{u_1}\right)^2(4 - \lambda^2) + \lambda'^2\right] \\ &\leq 32\chi_s(\tilde{\mathcal{C}}) + 8H_{\tilde{\mathcal{C}}}(\lambda). \end{aligned}$$

In order to apply Theorem 4.7 we need an upper bound for $\sum_{v \in \tilde{\mathcal{D}} \setminus U} v(y)$ in terms of the heights of u_1, u_2 . This bound is obtained by an application of a theorem by Zannier in [Zan93] which reads as follows.

Theorem 4.9 (Zannier). Let $\tilde{\mathcal{D}}$, U as before, $m \geq 2$ an integer, $\theta_1, \ldots, \theta_m$ U-units such that no subsum of $\theta_1 + \cdots + \theta_m$ vanishes. Then the U-integer $\theta_1 + \cdots + \theta_m$ satisfies

$$\sum_{v \in \tilde{\mathcal{D}} \setminus U} v(\theta_1 + \dots + \theta_m) \ge H_{\tilde{\mathcal{D}}}(\theta_1 : \dots : \theta_m) - \binom{m}{2} \chi_U(\tilde{\mathcal{D}}).$$

We are going to apply this theorem to the U-integer

$$y = u_1^2 + \lambda u_1 + u_2 + 1,$$

using the fact that

$$\begin{split} H_{\tilde{\mathcal{D}}}(u_1^2:\lambda u_1:u_2:1) &\geq \max\{2H_{\tilde{\mathcal{D}}}(u_1),H_{\tilde{\mathcal{D}}}(u_1)+H_{\tilde{\mathcal{D}}}(\lambda),H_{\tilde{\mathcal{D}}}(u_2)\}\\ &\geq \max\{H_{\tilde{\mathcal{D}}}(u_1),H_{\tilde{\mathcal{D}}}(u_2)\}. \end{split}$$

In particular, assuming that no subsum of the right term of equation (4.1) vanishes, we obtain the following.

Lemma 4.10. For every solution (y, u_1, u_2) of (4.1) such that no subsum of the right term vanishes, one has

$$H_{\tilde{\mathcal{D}}}(y) \ge \sum_{v \in \tilde{\mathcal{D}} \setminus U} v(y) \ge \max\{H_{\tilde{\mathcal{D}}}(u_1), H_{\tilde{\mathcal{D}}}(u_2)\} - 6\chi_U(\tilde{\mathcal{D}}).$$

Now we put together this last inequality with the results of Lemma 4.13 and we obtain that, for every solution of (4.1) there exist U-units a, b such that

$$\sum_{v \in \tilde{\mathcal{D}} \setminus U} \min\{v(a-1), v(b-1)\}\$$

$$\geq \frac{1}{4} \left(\max \{ H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b) \} - 6 \chi_U(\tilde{\mathcal{D}}) - 32 \chi_S(\tilde{\mathcal{C}}) - 8 H_{\tilde{\mathcal{C}}}(\lambda) \right).$$

Using the fact that $\chi_S(\tilde{\mathcal{C}}) \leq \chi_U(\tilde{\mathcal{D}})$ we obtain (4.15)

$$\sum_{v \in \tilde{\mathcal{D}} \backslash U} \min \{v(a-1), v(b-1)\} \geq \frac{1}{4} \bigg(\max \{H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b)\} - 38 \chi_S(\tilde{\mathcal{C}}) - 8 H_{\tilde{\mathcal{C}}}(\lambda) \bigg).$$

We can now apply Theorem 4.7 to deduce the following.

Proposition 4.11. Let $(y, u_1, u_2) \in \mathcal{O}_S \times (\mathcal{O}_S^*)^2$ be a solution of equation (4.1) such that no subsum of the right term vanishes, and the leading and constant term of the polynomials F, G are not zero. Let $\tilde{\mathcal{D}}, U$ be as defined in Lemma 4.6 and $a, b \in \mathcal{O}_U^*$ as defined in Lemma 4.8. Then either

(4.16)
$$\max\{H_{\tilde{\mathcal{C}}}(u_1), H_{\tilde{\mathcal{C}}}(u_2)\} \le 2^{12} \left(58\chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)\right) + 16H_{\tilde{\mathcal{C}}}(\lambda)$$

or a, b verify a multiplicative dependence relation of the form

$$a^r \cdot b^s = 1$$

for integers $(r,s) \in \mathbb{Z}^2 \setminus \{0\}$ with

(4.17)
$$\max\{|r|, |s|\} \le 5.$$

Proof. We suppose that inequality (4.16) does not hold and we want to prove the dependence relation for a, b. In order to apply Corvaja and Zannier Theorem 4.7 we are going to show that the left-hand side of (4.16) is greater than the right-hand side of (4.11). Our starting point is

$$\max\{H_{\tilde{\mathcal{C}}}(u_1), H_{\tilde{\mathcal{C}}}(u_2)\} > 2^{12} \cdot \left(58 \cdot \chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)\right) + 16H_{\tilde{\mathcal{C}}}(\lambda).$$

From Lemma 4.6 we know that

$$\chi_U(\tilde{\mathcal{D}}) \le 58 \cdot \chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)$$

and so we obtain that

$$\max\{H_{\tilde{\mathcal{L}}}(u_1), H_{\tilde{\mathcal{L}}}(u_2)\} > 2^{12}\chi_U(\tilde{\mathcal{D}}) + 16H_{\tilde{\mathcal{L}}}(\lambda).$$

Remember that our aim is to apply Theorem 4.7 and so we need to work with the maximum of the heights of a, b. For this reason we apply (4.13) which estimates the closeness of $H(u_i)$ and H(a), H(b) and we get

$$\max\{H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b)\} \ge \max\{H_{\tilde{\mathcal{D}}}(u_1), H_{\tilde{\mathcal{D}}}(u_2)\} - 32\chi_S(\tilde{\mathcal{C}}) - 8H_{\tilde{\mathcal{C}}}(\lambda)$$

$$\ge \max\{H_{\tilde{\mathcal{D}}}(u_1), H_{\tilde{\mathcal{D}}}(u_2)\} - 32\chi_U(\tilde{\mathcal{D}}) - 8H_{\tilde{\mathcal{C}}}(\lambda).$$

From these last two inequalities and the fact that $H_{\tilde{\mathcal{C}}} \leq H_{\tilde{\mathcal{D}}}$, we obtain the lower bound

(4.18)
$$\max\{H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b)\} \ge (2^{12} - 32)\chi_U(\tilde{\mathcal{D}}) + 8H_{\tilde{\mathcal{C}}}(\lambda).$$

In order to simplify the notation we put $H = \max\{H_{\tilde{\mathcal{D}}}(a), H_{\tilde{\mathcal{D}}}(b)\}$ and $\chi = \chi_U(\tilde{\mathcal{D}})$. We claim that

(4.19)
$$\sum_{v \in \tilde{\mathcal{D}} \setminus U} \min\{v(a-1), v(b-1)\} > 3 \cdot 2^{\frac{1}{3}} H^{\frac{2}{3}} \chi^{\frac{1}{3}}.$$

To prove the claim we observe that, from (4.15), it is enough to show that

$$\frac{1}{4} (H - 38\chi - 8H_{\tilde{\mathcal{C}}}(\lambda)) > 3 \cdot 2^{\frac{1}{3}} H^{\frac{2}{3}} \chi^{\frac{1}{3}}.$$

We define the function

$$f(t) = \frac{1}{4} \left(t - 8H_{\tilde{\mathcal{C}}}(\lambda) \right) - 3 \cdot 2^{\frac{1}{3}} t^{\frac{2}{3}} \chi^{\frac{1}{3}} - 38/4\chi$$

and we notice that our claim is equivalent to f(H) > 0. Now the function f is an increasing function for $t \ge 2^{10}\chi + 8H(\lambda)$, therefore it is enough to prove it for $H = (2^{12} - 32)\chi > 2^{10}\chi$. Hence the claim is equivalent to

$$\frac{1}{4}(2^{12} - 32)\chi - 3 \cdot 2^{\frac{1}{3}}(2^{12} - 32)^{\frac{2}{3}}\chi > 38/4\chi.$$

With some algebraic manipulations one gets

$$\begin{split} &\frac{1}{4}(2^{12}-32)\chi-3\cdot 2^{\frac{1}{3}}(2^{12}-32)^{\frac{2}{3}}\chi\\ &=2^{\frac{10}{3}}(2^{7}-1)^{\frac{2}{3}}\left[\frac{1}{4}2^{\frac{5}{3}}((2^{7}-1)^{\frac{1}{3}}-3\cdot 2^{\frac{1}{3}}\right]\chi\\ &=40\cdot 6\cdot \left[2^{-\frac{1}{3}}\cdot 2^{\frac{13}{6}}-3\cdot 2^{\frac{1}{3}}\right]\chi\\ &=40\cdot 6\cdot \left[2^{\frac{1}{3}}(2^{\frac{5}{3}}-3)\right]\chi>40\chi, \end{split}$$

which proves the claim. Now we can apply Theorem 4.7 which implies that a, b verify a multiplicative dependence relation of the form $a^rb^s = 1$ for some integers r, s not both zero. The same theorem gives the bound (4.12) and hence, together with (4.18) and (4.15), we obtain

$$\frac{H}{\max\{|r|,|s|\}} > \frac{1}{4}H - 10\chi > \frac{1}{5}H.$$

Therefore we get $\max\{|r|,|s|\} \leq 5$, as desired.

The conclusion of Proposition 4.11 gives us a multiplicative relation of dependence between a, b instead of u_1, u_2 . However, this relation is guaranteed by Lemma 3.14 in [CZ08] which gives us the following result:

Lemma 4.12 ([CZ08]). In the previous notation, if a multiplicative relation of the form $a^r \cdot b^s = \mu$ holds for a constant $\mu \in \kappa$, then either one between a and b is constant or u_1, u_2 satisfy a multiplicative dependence relation of the same type.

Now we go back to Theorem 4.2. Here we should take care of the constant term of the polynomial G in a different way as in the constant case. In detail the vanishing of this term does not directly imply an explicit bound for the degree of the images $f(\mathcal{C})$ as in the split function field case; here we should apply again the whole machinery in order to explicitly find the unit u_1 and so reduce the problem to equation $y^2 = \mu + u_2 + 1$, which was already solved in the split case and gives

the desired bound. For readability reasons we split the proof of Theorem 4.2 in two cases: Lemma 4.13 for the case in which the constant coefficient of G is not zero, and Lemma 4.14 for the other case. Clearly the two lemmas together give Theorem 4.2.

Lemma 4.13. Suppose that the constant term of the polynomial G does not vanish, i.e., with the notation of Theorem 4.2, every solution $(y, u_1, u_2) \in \mathcal{O}_S \times (\mathcal{O}_S^*)^2$ of equation (4.1)

$$y^2 = u_1^2 + \lambda u_1 + u_2 + 1$$

also satisfies

$$\left(\frac{u_1'}{u_1}\right)^2 (4 - \lambda^2) + \lambda^2 \left(\frac{\lambda'}{\lambda}\right)^2 \neq 0.$$

Then one of the following conditions holds:

- (i) a subsum on the right term of (4.1) vanishes;
- (ii) u_1, u_2 verify a multiplicative dependence relation of the form $u_1^r \cdot u_2^s = \mu$, where $\mu \in \kappa$ is a scalar and r, s, are integers, not both zero, such that $\max\{r, s\} \leq 5$;
- (iii) the following bound holds:

$$\max\{H_{\tilde{\mathcal{C}}}(u_1),H_{\tilde{\mathcal{C}}}(u_2)\} \leq 2^{12} \cdot \left(58 \cdot \chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)\right) + 16H_{\tilde{\mathcal{C}}}(\lambda).$$

Proof. We start by assuming that (i), (ii) and (iii) are not satisfied and we are going to find a contradiction. First of all we note that, if (i) is not satisfied, no subsum of (1.1) can vanish. Moreover the polynomials F and G defined in Lemma 4.5 could not be constant because the vanishing of their leading coefficients would imply some multiplicative relation between u_1 and u_2 which is excluded by (ii). The same is true for the constant coefficient of F (which is u'_2/u_2); it cannot be zero otherwise u_2 would be constant. Moreover, by our assumptions, the same holds for the constant coefficient of G. Hence both F and G are non-constant polynomials whose constant coefficients are not zero.

Since we excluded the case where the leading and constant coefficients of F and G vanish, we can apply (4.11) and obtain a multiplicative relation between $a = u_1 \alpha^{-1}$ and $b = u_1 \beta^{-1}$; this follows from the fact that inequality (4.16) is excluded by (iii). From this relation, applying (4.12), we get that either a or b is constant or u_1 and u_2 verify a multiplicative relation of the same type. The former case would imply that the height of u_1 (or u_2) would be the same as the height of α (resp. β) so it would be less than or equal to $8\chi_S(\tilde{\mathcal{C}})$ (resp. $32\chi_S(\tilde{\mathcal{C}})$); but this contradicts our assumption that (iii) does not hold and hence it is excluded. The latter case is precisely (ii) that was assumed to be false. In both cases we get a contradiction and this concludes the proof.

Lemma 4.14. Suppose that the constant term of the polynomial G vanishes, i.e., with the notation of Theorem 4.2, every solution $(y, u_1, u_2) \in \mathcal{O}_S \times (\mathcal{O}_S^*)^2$ of equation (4.1) also satisfies

(4.21)
$$\left(\frac{u_1'}{u_1}\right)^2 (4 - \lambda^2) + \lambda^2 \left(\frac{\lambda'}{\lambda}\right)^2 = 0.$$

Then one of the following conditions holds:

- (i) (y, u₁, u₂) satisfy an equation whose solutions verify conclusions of Theorem 4.2.
- (ii) u_1, u_2 verify a multiplicative dependence relation of the form $u_1^r \cdot u_2^s = \mu$, where $\mu \in \kappa$ is a scalar and r, s, are integers, not both zero, such that $\max\{r, s\} \leq 5$;

Proof. The first trivial case is the case in which λ is constant which is excluded since we are assuming that the threefold defined by λ is not trivial. The second case is the case in which λ is a non-constant S-unit. In this case we obtain, in the ring \mathcal{O}_S , the following identity (here we can enlarge S so that it contains every point for which $\lambda = 2$):

(4.22)
$$\left(\frac{u_1'}{u_1}\right)^2 = -\frac{\lambda^2}{4-\lambda^2} \left(\frac{\lambda'}{\lambda}\right)^2.$$

Now we observe that, by Dirichlet Unit Theorem, the ring \mathcal{O}_S^* is finitely generated modulo constants, so every $u_1 \in \mathcal{O}_S^*$ is of the form $\mu \cdot v_1^{a_1} \cdots v_h^{a_h}$ for some $\mu \in \kappa$ and $v_1, \ldots, v_h \in \mathcal{O}_S^*$. Therefore we have

$$\frac{u_1'}{u_1} = \sum_{i=1}^h a_i \frac{v_i'}{v_i}.$$

Being $\lambda \in \mathcal{O}_S^*$ the right-hand side of equation (4.22) could also be expressed in the v_i and their derivatives; in particular (4.22) becomes an equation in the unknown a_i and this equation will have a unique (for given λ and S) solution in the a_i . Hence u_1 will be uniquely determined up to a constant factor and therefore its height will be a constant. So we can assume that $u_1 = af$ for a constant $a \in \kappa$ and a fixed S-unit f. This leads us to consider equation $y^2 = a^2 f^2 + \lambda a f + u_2 + 1$. We claim that this case gives (i). The claim follows from a repetition of all the considerations done until now for equation (4.1): we obtain the same estimates with different polynomials \tilde{F}, \tilde{G} . Again we look at the vanishing of the constant and leading coefficients and this time we found that the case in which the constant coefficient of the new polynomial \tilde{G} vanishes gives us either $u_1 = 0$ or $u_1 = f$ where a=1. In both cases this reduces the problem to the equation $y^2=\mu+u_2+1$, where μ is now fixed, which has already been treated in the split function field case and gives (i). The case in which the constant term of \hat{G} is not zero is precisely one of the cases of (i) and this concludes the proof of the claim.

Finally we prove Theorem 1.6 using the previous theorem.

Proof of Theorem 1.6. As in Lemma 4.1, after possibly passing to a double cover of $\tilde{\mathcal{C}}$, a section

$$\sigma: \tilde{\mathcal{C}} \setminus S \to X$$

will be of the form

$$\sigma: P \mapsto (u_1(P), y(P), P),$$

where the S-unit u_1 and the S-integer y verify equation (4.1) for an S-unit u_2 . In this setting we can apply Theorem 4.2 and conclude that one of (i), (ii), (iii) holds.

Let us analyze every case.

- In the first case (i) we have that some subsum of $u_1^2 + \lambda(P)u_1 + u_2 + 1$ will vanish. Hence $\sigma(\mathcal{C})$ is either a line or a conic (recall that being λ non-constant its height is at least one).
- In the second case (ii) we have a multiplicative relation between the two S-units of the form $u_1^r = u_2^s \cdot \mu$ for a scalar $\mu \in \kappa$ and two integers r, s with absolute value lesser or equal than 5. From this it follows that $\deg \sigma(\mathcal{C}) \leq H_{\tilde{\mathcal{C}}}(u_1) + H_{\tilde{\mathcal{C}}}(y) \leq 20$.
- In the last case (iii) we have that $\max\{H_{\tilde{\mathcal{C}}}(u_1), H_{\tilde{\mathcal{C}}}(u_2)\}$ is bounded above by $2^{12} \cdot \left(58 \cdot \chi_S(\tilde{\mathcal{C}}) + 28H_{\tilde{\mathcal{C}}}(\lambda)\right) + 16H_{\tilde{\mathcal{C}}}(\lambda)$.

In both cases this implies that there exist constants $C_1 \leq 2^{14} \cdot 58$ and $C_2 \leq 2^{14} \cdot 28$ that verify the conclusion of the theorem.
